

POSTCITY House Rules

Welcome to POSTCITY!

Each and every person who enters the premises governed by these House Rules thereby tacitly consents to the possibility of being stopped and checked by the event promoter's security personnel. All visitors are obliged to comply with any and all instructions issued by the event promoter and personnel assigned to accompany guests.

If overcrowded conditions threaten to occur in a particular area of the event venue, a part of that area may be closed or access to it restricted.

Please keep in mind that the premises of POSTCITY constitute a decommissioned industrial facility and that due to the facts & circumstances of its physical state—such as, but not limited to, heavy doors (some of which operate automatically), low ceilings, uneven floors, and protruding equipment or components thereof—entering these premises entails increased danger.

Please refrain from excessive noise, and be considerate of others. Thank you!

POSTCITY is not a playground. Children are permitted to enter only if the parent/guardian accompanying them assures that they move about these premises in a way that minimizes risk.

Dogs and other pets are prohibited.

It is prohibited to bring onto these premises any kind of weapon or object that could be used as a weapon, as well as any and all substances that could pose a danger, fireworks of any kind, flammable liquids, alcoholic beverages, cans, glass bottles, drugs and other intoxicants, as well as racist, xenophobic, national socialist, sexist or political propaganda material.

It is prohibited to bring the following objects onto, and to ride them within, these premises: bicycles and tricycles, scooters, roller skates, skateboards and other similar means of locomotion.

Nowhere on these premises may objects of any kind whatsoever be deposited and left unattended without the express consent of the event promoter. The same applies to parking vehicles and other objects anywhere on the premises of POSTCITY, and especially in the vicinity of the entrance on Waldeggstraße and in POSTCITY's courtyard. All entrances to the building and the courtyard, as well as stairwells and corridors are emergency exits/escape routes and may under no circumstances be obstructed. Parking is permitted only in the short-term parking spaces marked as such, and in the garages (e.g. Hauptbahnhof parking deck and Wissensturm underground garage).

Visitors are prohibited from entering these premises before or after the Festival's regular opening hours.

It is prohibited for visitors to go onto these premises' roof or roof-like surfaces, except where explicitly allowed.

It is prohibited for visitors to ride any of the freight elevators.

Please help us recycle by making use of the receptacles provided and putting your trash in the proper bin.

Smoking is prohibited throughout the premises.

You enter strictly at your own risk. Ars Electronica Linz GmbH & Co KG assumes no liability whatsoever.

In case of danger (e.g. fire, accident, outbreak of violence), please summon the security personnel on duty on the premises or the appropriate first-responder organizations as quickly as possible.
